AIRSERVICES MESSAGE TO AVIATION FIRE FIGHTERS: "WE'LL GIVE YOU NOTHING" VOTE YES FOR INDUSTRIAL ACTION

FOR THE INFORMATION OF MEMBERS:

Last Friday UFUA negotiators gathered at Airservices' Tullamarine HQ for the long-awaited (three weeks) response to our enterprise bargaining log of claims.

All Airservices served up was.....well, nothing.

- NO pay rise over and above the lame 11.2% over three years they have been offering since November
- NO putting minimum staffing levels (inclusive of leave relief) in the agreement to guard against compromised service obligations and excessive overtime
- NO to clearer guidelines on overtime to prevent fatigue
- NO to increasing allowances
- NO to lifting superannuation to 15.4% in line with other Commonwealth employees
- Even NO to people having the right to not have their photo used without their permission.

Three months into bargaining talks, Airservices has not agreed to a single UFUA claim.

The path from here is unfortunately well travelled and clear. We are left with no option but to take industrial action to win aviation firefighters a fair agreement.

This time around there will be no delay. Immediately after our meeting on Friday the UFUA submitted a Protected Action Ballot Order to the Fair Work Commission. Since then, the UFUA has responded to Airservices' legal team's requests for clarification over the actions we propose to take. Today Airservices must inform the Commission as to whether it will dispute any of those actions.



Once the Commission has issued its decision as to which actions can be put to members in the ballot, you will be contacted via email (Truevote online ballot) asking if you are in favour of taking industrial action. Vote **YES** to all questions. Make sure you and all your workmates vote **YES**. A unanimous **YES** vote will be a strong first step in showing Airservices the intent and sentiment of our membership.
