PIA Ballot Action Item 3

An unlimited number of stoppages of work for 4 hours duration

From 20:00 UTC on Sunday, 14 April 2024 to 00:00 UTC on Monday, 15 April 2024, a 4-hour work stoppage will commence across all stations. During the 4-hour work stoppage, all ARFFS stations will be nil aviation rescue fire services.

This will be protected industrial action authorised under the Fair Work Act 2009.

All UFUA members rostered to work during these hours must not attend work during these hours, with the exception of Fire Control Centre Operators (FCCO) (see below).

During the Work Stoppage

Please carefully observe the local time zones for the period of the stoppage:

Fire Control Centre Operators

Members who are performing duties as a Fire Control Centre Operator during the period of any stoppage will remain in the Fire Control Centre to transfer any incoming emergency calls to local emergency response agencies. This is an essential element of the safety undertaking the UFUA has provided to the Fair Work Commission and must be observed.

Fire Commanders

Fire Commanders must issue a 'Notice to Airmen' (NOTAM) on **Tuesday 2 April**, providing seven clear working days' notice that ARFFS category (level of service) will not be available during the 4-hour period of the stoppage. When issuing a NOTAM, Fire Commanders must indicate ARFFS coverage will be withdrawn due to UFUA members taking protected industrial action. Fire Commanders can use the following message to airlines when issuing the NOTAM:

"The withdrawal of ARFFS coverage is authorised by protected industrial action under the Fair Work Act 2009. Aviation Rescue Fire Fighters at Airservices are currently taking protected industrial action

because Airservices refuses to respect us, to value our dedication and service to keeping the air travelling public safe".

Having been advised of the NOTAM, airlines can cancel or reschedule flights accordingly, without compromise to public safety.

During the Notice Period

Stay closely tuned to your Workplace Delegates, Health and Safety Representatives and Branch Committee of Management for updates as they arise.

If you have any concerns about the nature or detail of the actions that you wish to raise, email your Workplace Delegates, Health and Safety Representatives and Branch Committee of Management.

Health and Safety

The safety of workers and the safety of the travelling public are paramount.

Taking protected industrial action is your right

Remember, this will be protected industrial action, 100% authorised by the ballot we ran under the *Fair Work Act 2009.* There are large penalties for anyone who tries to interfere with your right to take protected industrial action.

We have been forced to take this action by Airservices' refusal to respect and recognise us in negotiations for the new EA. We need to demonstrate our strength to them by carrying out this action in a determined and united manner.

Stay informed

Updates on additional PIA actions will follow in due course. To date and including this update, 21 PIA Actions have been sanctioned and announced by the Branch Committee of Management.

MEMBERS MUST NOT UNDERTAKE ANY PIA ACTIONS THAT HAVE NOT BEEN SANCTIONED BY THE BRANCH COMMITTEE OF MANAGEMENT. THIS GUARANTEES THAT MEMBERS ARE AT ALL TIMES PROTECTED WHEN EXERCISING THEIR RIGHTS TO PARTICIPATE IN PROTECTED INDUSTRIAL ACTION.
