As all members are aware, the UFUA and Airservices have recently finalised the drafting for the new 2024-2027 Enterprise Agreement. Today Airservices will release the following documents for consideration:

- **The proposed Enterprise Agreement with changes highlighted.**
- **The proposed Enterprise Agreement (clean copy).**
- **Summary of key changes (detailed clause by clause evaluation).**

CONSIDERATION/VOTING SCHEDULE

Wednesday 22 May 2024 – Airservices to publish information package.

Thursday 23 May 2024 – Formal Consideration period starts.

Wednesday 29 May 2024 – Formal Consideration period ends.

Thursday 30 May 2024 - Voting opens.

Friday 7 June 2024 (5pm AEST) - Voting closes and results announced.

Whilst it's desirable that members submit their vote well before voting closes at 5pm AEST Friday 7 June, if members choose to extend their consideration period through to the 7th there is effectively a 16-day window to consider the detailed documents.
