MEMBERSHIP APPLICATION

ADVICE TO MEMBERSHIP APPLICANTS

A member of the United Firefighters' Union of Australia (the Union) has financial obligations arising from membership. Those obligations are:

- (a) To meet any fine imposed for any offence against the Rules [r. 82(4)(a)(ii) and r. 82(5)]
- (b) To pay to the Aviation Branch of the Union such membership subscriptions as may be determined from time to time by the Branch [r. 80(1)(a)] and expect where such a subscription is paid by payroll deductions or Direct Debit, to pay the annual subscription either in one advance payment in July of each year or quarterly in advance by four equal payments on or before the quarter days being the last days of the months of March, June, September and December [r. 80(2)].
- (c) To pay such levies as may be imposed on members by a Branch meeting or Branch Committee of Management meeting [r. 81].

A member may resign from the Union. The circumstances and the way a member may resign are set out in r. 8 of the Union's rules:

8 - Resignation from Membership

- (1) A member of the Union may resign from membership by written notice addressed and delivered to the Secretary of the Branch to which the member belongs.
- (2) A notice of resignation from the Union takes effect:
 - (a) Where the member ceases to be eligible to become a member of the Union;
 - (i) On the day on which the notice is received by the Union; or
 - (ii) On the day specified in the notice, which is a day not earlier than the day when the member ceases to be eligible to become a member; whichever is the later; or
 - (b) In any other case:
 - (i) At the end of two weeks after the notice is received by the Union; or
 - (ii) On the day specified in the notice, whichever is later.
- (3) Any dues payable but not paid by a former member of the Union in relation to a period before a member's resignation from the Union took effect, may be sued for and recovered in the name of the Union, in a court of competent jurisdiction, as a debt due to the Union.
- (4) A notice delivered to the Branch Secretary shall be taken to have been received by the Union when it was delivered.
- (5) A notice of resignation that has been received by the Union is not invalid because it was not addressed and delivered in accordance with Sub-Rule (1).
- (6) A resignation from membership of the Union is valid even if it is not affected in accordance with this Rule if the member is informed in writing by or on behalf of the Union that the resignation has been accepted.
